Signor Deluso, Synopsis

Gorgibus is forcing his daughter Célie to marry the wealthy Valère, but she is in love with Léon who is studying abroad in Paris, but has promised to return and marry her. A series of mistaken assumptions and quarrelling ensues after Célie faints in the town square and loses her locket with a portrait of Léon inside. Signor Deluso tries to revive her, leading his wife Clara to suspect they are lovers. When Signor Deluso finds Clara looking at the portrait in Célie's lost locket, he immediately assumes that the young man depicted is Clara's lover. In turn, Célie assumes that Léon has been unfaithful to her with Clara, and Léon assumes that Célie has been unfaithful to him with Signor Deluso. The maid, Rosine, arrives to clear up the various misunderstandings between the couples.

The Medium, Synopsis

Monica, the daughter of Madame Flora ("Baba"), and Toby, a mute boy living with them, are playing while Madame Flora is away. When she returns, she is furious that they are not ready for the seance she has planned. When the three guests arrive for the seance, Monica pretends to be the teenage daughter of one and the baby son of another. Suddenly, Madame Flora stops the seance and sends the customers away. She tells Monica she felt a spectral hand clutch her throat during the seance. She suspects Toby at first, but as Monica tries to comfort her Flora hears a voice imitating Monica's performance at the seance.

Act II

A few days later, Monica is watching Toby perform a puppet show for her. She runs off as Baba enters; the medium tries cajole Toby into confessing that he was the one who touched her during the séance. When he does not answer, she begins to beat him, but is interrupted by visitors, the three clients from the previous séance. Flora tries to give them their money back and convince them they have been cheated, but they refuse to believe her. She throws them out, and despite Monica's protests, throws Toby out too. Monica goes to her room, and Baba, frightened by what she has experienced, drinks herself to sleep. Toby returns to retrieve the necklace given to him by Monica. Flora awakes, and thinking Toby is the spirit, she kills him.
