The Long-Term Trend in Contingent Faculty Employment

What is in this Report

This is a data report to accompany the working paper, "Faculty Diversity and Minoritized Student Outcomes: An Analysis of Institutional Factors" from the Center for the Study of Academic Labor (CSAL) at Colorado State University (Curtis 2021). That paper assembles data from multiple components of the US Department of Education's Integrated Postsecondary Education Data System (IPEDS), which effectively serves as a census of US higher education, in order to examine the relationship between faculty diversity at predominantly white institutions (PWI) and degree outcomes for minoritized students there.¹ In the process of compiling data for the working paper analysis, I was reminded that the National Center for Education Statistics (NCES) no longer produces detailed tabulations of the IPEDS data on faculty members. That lack of published tabulations had prompted me in 2014 to produce my own tabulation of thencurrent data on the employment status of instructional staff members, broken out by institution type, racial category, and gender (Curtis 2014).

Given that the NCES publication situation has not improved since 2014, I decided to produce three updated data reports including trend data over time. In addition to this report, I have prepared an update of the "faculty gender equity indicators" I initially released in 2006 with my colleague Marty West (West and Curtis 2006), and a separate report compiling trend data on diversity in faculty employment. These other reports may be found at the CSAL website (https://csal.colostate.edu/). The primary purpose of this report is to compile and make available long-term trend data on faculty employment, in a format more accessible to the general higher education audience than those produced by NCES. As such, the body of the report provides figures that highlight important aspects of employment status trends, with detailed tables provided in an appendix. I will also make the data files used in the report available on the CSAL website. Because this is primarily a data report. I do not attempt a comprehensive review of the research literature on the growth and consequences of contingent academic employment. (Recent contributions to that literature include Kezar et al. 2019, Finkelstein et al. 2016, and Hearn and Burns 2021.)

The "note on the data" section at the end of the report provides important further details regarding the data sources and tabulation process, but I want to provide a couple of basic notes at the outset. The data are compiled for all degree-granting institutions that reported employing instructional staff in each respective year. This report tabulates only counts of instructional staff members by employment status and institutional category. It does not break out tabulations by gender or by racial categories, since those breakouts are provided in greater detail in the two other data reports I am releasing through CSAL at the same time.

There are two other major differences between this report and the other two data reports on faculty employment. First, this report includes tabulations of graduate student employees in the figures and tables that refer to "instructional staff," along with tables and figures limited to faculty. This report presents both versions, with only the totals and

percentages of the total differing, to allow users to choose the tabulations most appropriate for their purpose. The detailed appendix tables include the actual numbers in each category, to allow users to create new tabulations using different combinations.

Note that all the tables and figures in this report use headcounts (numbers of individuals) of staff members. IPEDS does not collect data on instructional workload, so we cannot say definitively based on IPEDS data who is doing the teaching across the categories of colleges and universities.

The second difference in this report is that the first segment of the long-term trends depicted here, between 1975/1976 and 2009, makes use of published figures from NCES reports. Beginning with the 2011 figures, the overall trend data are my compilation of raw data from IPEDS, since the published NCES tabulations beginning with that year do not distinguish faculty members employed full-time by their tenure status.² In this and other reports, I disaggregate the employment status of faculty members in terms of tenure status, full-time status, and the type of institution where they are employed. IPEDS data make such an analysis possible but require additional attention to detail.

As of this writing we cannot know the full consequences of the covid-19 pandemic, currently in its third academic year of significant disruption to higher education, for academic employment. There are strong indications that the pandemic has exerted a disproportionate impact on faculty members employed in contingent positions (AAUP 2021). The most recent data presented here are as of fall 2019 and thus represent the status prior to the pandemic

Employment Status Trend




Figure 1. Instructional Staff Employment Status, 1975/1976 to 2019




Figure 2. Contingent Employment among Instructional Staff, 1975/1976 to 2019




Figure 3. Faculty Employment Status, 1975/1976 to 2019




Figure 4. Contingent Employment among Faculty, 1975/1976 to 2019

Figure 1 illustrates the full long-term trend in employment status categories relative to the whole instructional staff, which includes all faculty and graduate student employees; the proportions for faculty alone are depicted in figures 3 and 4. The total counts generating figures 1 and 2 are provided in appendix table 1, along with the actual years of available data. In figure 1, only the beginning and ending columns are labeled with percentage values, due to the complexity of the chart.

The proportion of instructional staff members who were employed full-time in tenured faculty appointments declined steadily from 29 percent in 1975/1976 to 17 percent in 2007, where it has remained since. The tenure-track faculty proportion declined relatively rapidly between 1975/1976 (16 percent) and 1993 (10 percent), and then more slowly all the way until 2011, when it reached 7 percent and has remained at that level to 2019. The trend in employment of full-time nontenure-track faculty members has been generally upward, although the increase has been slow and not linear since that proportion reached 14 percent in 1989. It stands at 17 percent in 2019 after an uptick in recent years. The part-time faculty proportion rose steadily until peaking at 42 percent in 2011 and has dropped slightly since then.³ Although the chart depicts some fluctuation in the proportion, graduate student employees have constituted roughly 20 or 21 percent of the full instructional staff for most of the period. (Graduate employees are

almost exclusively employed by universities with larger graduate programs, so that their representation is actually greater at those institutions than shown in figure 1. The figures broken out by institutional category in the following section make this point clear.)

It is important to bear in mind that these category percentages are all relative to the total number of instructional staff members, which grew steadily from 1975/1976 to 2011 and has since remained roughly constant at 1.8 million. So, for example, the number of tenured faculty members actually grew between 1975/1976 and 2011, but the growth in other employment status categories was more rapid. Table 1 in the appendix provides all of the total counts. Figure 2 depicts a simpler, more significant trend, the long-term growth of contingent employment in the instructional staff. The employment status categories included within the contingent proportion of instructional staff are fulltime non-tenure-track and part-time faculty and graduate student employees. This proportion of the instructional staff employed contingently grew from 55 percent in 1975/1976 to 76 percent in 2009, where it has remained since.

Table 2 in the appendix shows one way of organizing periods of change in academic employment within the long-term trend. It breaks the change in counts of instructional staff members employed in each of the categories into four roughly equal periods, the latter three of them representing decades. (The greater length

of the first period, from 1975/1976 to 1989, is due to the absence of published data between those time points.) The fluctuations in growth, and even decline, of the various categories across the four time periods are interesting and undoubtedly worthy of further analysis. The most recent decade, between 2009 and 2019, registered only 2.5 percent growth in the size of the total instructional staff, with the tenure-track and part-time faculty categories declining in size while the full-time non-tenure-track faculty and graduate student employee categories each grew by more than 12 percent.

As noted above, figures 3 and 4 show the trends in employment status for faculty members only. The employment status category counts that generate the percentages in these two figures, shown in appendix table 3, are the same as those used to create figures 1 and 2, but a different denominator results in different percentages. Full values underlying the figures are in table 3.

Given that, the patterns of change over time shown in figure 3 are the same as those in figure 1, with the difference being in the percentage values. The proportion tenured among all faculty shrank from 36 percent in 1975/1976 to 21 percent in 2007 and has remained at that level. The proportion of faculty members on the tenure track dropped sharply in the first decade of the chart, then declined slowly to 9 percent in 2011, where it has held steady since. Full-time faculty members not on the tenure track were 13 percent of all faculty in 1975/76, and that percentage

has risen, slowly and not without fluctuation, to reach 21 percent in 2019, the same proportion as tenured faculty. Faculty members employed part-time already made up 31 percent of the faculty in 1975/1976, became the majority (50 percent) in 2007, and peaked at 51 percent from 2009 to 2013. Since then, the percentage of part-time faculty has decreased slightly to 49 percent as the proportion of appointments made fulltime but off the tenure track increased.

Figure 4 combines the contingent categories among the faculty, full-time non-tenure-track and part-time, and charts the growth of contingent employment over the full period. The trend is the same as that depicted in figure 2, with the difference once again in the percentage values. Contingent employment among faculty members rose from 44 percent in 1975/76 to 71 percent in 2011, but has remained essentially constant at 70 percent since 2009.

Table 4 in the appendix breaks the full trend for faculty employment status into time periods, as described for table 2 above. The final decade demarcated in table 4 is perhaps even more dramatic than in table 2, as the total count of faculty members remained essentially unchanged from 2009 to 2019. What did change was the composition of the faculty, with tenure-track and part-time numbers declining by 4 percent each while the number of full-time non-tenure-track appointments rose by nearly 13 percent. The number of tenured appointments grew by under 2 percent, the smallest growth of any of the periods shown.

Figure 5 provides a different visual depiction of both instructional staff and faculty employment status at the beginning and end of the full period. (Again, the counts producing the columns are the same, the differences in percentages are due to differing denominators.) Over four decades, the proportions of full-time tenured and tenure-track faculty members declined substantially, while the proportions of individuals employed in contingent faculty positions (full-time non-tenure-track and part-time) grew to become the majority. Graduate student employees formed a relatively consistent proportion of the instructional staff over the period.

Employment Status Trend by Institutional Type

There are important distinctions in employment status for instructional staff members working at different types of colleges and universities, and two methods of categorizing institutions are presented here: institutional category, based on a condensed version of the Carnegie Classification, and institutional control. The trends in this section cover four points in time, fall 1995, 2005, 2015, and 2019 (the most recent data available).

Instructional staff employment by institutional type





Figure 6. Instructional Staff Employment Status, by Institutional Category, 1995–2019




Figure 7. Contingent Employment among Instructional Staff, by Institutional Category, 1995–2019

Figures 6 and 7 depict the changes in the instructional staff, including graduate student employees, across these four time points.⁴ Figure 6 includes a separate chart for each institutional category; this makes the individual charts small, and yet the differences are large enough to be clear. Full details on the counts used to produce figure 6 are in appendix table 5, where we can also see that the staff size of the institutions increases dramatically as we move through the categories. Research universities employed nearly twice as

many instructional staff members as associate's degree colleges at only about one-eighth the number of institutions.

Associate's degree (or community) colleges predominantly employ part-time faculty members, and that proportion changed only slightly from 63 to 67 percent. Many community colleges do not grant tenure to their full-time faculty members, but among those that do, there was a slight shift from tenured to nontenure-track appointments over the period. Community colleges do not employ graduate students.⁵

The overall trends in employment status shown in the previous section are most evident in the baccalaureate/small master's and master's/doctoral institutional categories. The proportions of tenured and tenure-track faculty members declined at both categories of institutions, with the tenured proportion shrinking more rapidly at master's and doctoral universities. Both categories of institutions employed an increasing number of full-time non-tenure-track faculty members, with the proportion at baccalaureate colleges and small master's universities substantially higher. Employment of part-time faculty members grew in both categories of institutions and jumped dramatically between 1995 and 2005 at master's and doctoral universities. The proportion of part-time faculty was higher in the baccalaureate/small master's category in 1995 and then rose relatively slowly, while at master's/doctoral universities the proportion of part-time faculty members peaked in 2015 and then declined slightly in 2019. Neither of these two institutional categories employs large proportions of graduate students, although it is interesting that graduate student employees were a smaller proportion of

the total instructional staff at master's and doctoral universities in 2019 than in 1995.

Research universities are characterized by a large proportion of graduate student employees, relatively lower rates of parttime faculty employment, and a less dramatic shift in employment status over the period than seen in other institutional categories. Graduate employees made up a consistent 41 to 44 percent of the total instructional staff at research universities during the period, while the part-time faculty proportion grew only slightly from 12 to 15 percent. The most substantial shift in employment at research universities was the decrease in the proportion of tenured faculty members from 25 to 19 percent, a relatively modest decline. The tenure-track faculty proportion remained essentially unchanged, while the non-tenure-track segment grew slightly from 13 to 16 percent.

Figure 7 charts the growth of contingent employment in the instructional staff at the four institutional categories over time. Contingent appointments were in the majority for all four categories throughout, with the largest and most consistent proportion at associate's degree (community) colleges. The growth in contingent employment is most evident at the baccalaureate/small master's and master's/doctoral institutions. Contingent employment at research universities was already more common in 1995 that at either of those two categories, given the large proportion of graduate student employees, and then grew relatively more slowly. In the end, contingent appointments represented about threequarters of the total instructional staff in the four-year institution categories as of fall 2019.




Figure 8. Contingent Employment among Instructional Staff, by Institutional Category and Control, 1995–2019

Figure 8 further describes the growth of contingent employment among the instructional staff by adding institutional control to category; it is separated into side-by-side charts for public and private institutions.⁶ At the associate's degree level, contingent employment in public community colleges was high at the beginning of the period (78 percent) and grew slightly to 82 percent by 2019. Among private associate's colleges the levels of contingency were higher and grew more sharply, but it should be noted that there are relatively few private notfor-profit colleges in this category.

Among baccalaureate and small master's institutions, there was clear growth in

contingency in both public and private sectors, and both ended the period at 73 percent contingent employment among instructional staff. In the master's/ doctoral category, we see almost parallel growth trends for public and private universities, with a rise of 16 percentage points in each sector and the private institutions consistently employing a higher proportion of contingent instructional staff. Public research universities employed a somewhat greater proportion of contingent instructional staff in 1995 than did private (68 and 61 percent, respectively) but growth in contingency essentially eliminated that difference by fall 2019, with contingent

employment ending at 73-75 percent in both sectors.

The figures in this section show the importance of making observations regarding contingent employment that are specific to the type of institution being considered. Although the decline in tenure-line faculty appointments has been observed across institution types, the specific forms of contingent employment vary.

Faculty employment by institutional type






Figure 9. Faculty Employment Status, by Institutional Category, 1995–2019

Figures 9-11 depict employment status for faculty alone, with the same breakouts as in figure 6-8. Figure 9 provides separate charts of the trend in faculty employment status for the four categories of institutions. As noted above, the counts by faculty employment status are the same as used in the previous section, but the percentages differ because they are based on a denominator of faculty only. (Full details on the counts by category are in appendix table 7.)

Part-time faculty members make up twothirds of the faculty at associate's degree colleges, with a slight growth from 64 percent in 1995 to 68 percent in 2005 and an essentially constant proportion in the latter years. Among full-time community college faculty members, there was a slight shift toward non-tenure-track appointments. In the baccalaureate/small master's category, we see a more pronounced shift from tenure-line to contingent positions over the period. Tenured and tenure-track positions combined were 40 percent of all faculty in 1995 and declined to 26 percent in 2019, while the two contingent status categories combined grew from 61 percent in 1995 to 74 percent in 2019.7

The master's and doctoral university category saw a more dramatic shift, from 54 percent combined tenure-line appointments to 29 percent, and the growth of contingent positions from 46 percent in 1995 to 71 percent in 2019. At research universities, when we remove the large category of graduate student employees and look only at faculty positions, the dramatic shift to contingent employment is also clear. Tenured and tenure-track appointments were the majority (57 percent) of the research university faculty in 1995 and declined to 46 percent by 2019. The two non-tenuretrack categories combined grew from 43 percent in 1995 to a "new majority" of 54 percent in 2019.

Figure 10 charts the growth of contingent faculty employment for the four institutional categories from 1995 to 2019. Contingency is most prevalent at community colleges, where the proportion rose from 78 to 83 percent over the period. The majority of faculty members at baccalaureate/small master's institutions (60 percent) were already employed contingently in 1995, and that majority grew to 74 percent in 2019.

In both the master's/doctoral and research university categories, faculty employment shifted from predominantly tenure-line to predominantly contingent during this period. That shift was more rapid at master's and doctoral universities, from 46 percent contingent in 1995 to 71 percent in 2019, a rise of 25 percentage points. In research universities, the faculty moved from 43 percent contingent in 1995 to 54 percent in 2019, an increase of 9 percentage points.






Figure 11 adds the other aspect of institution type, institutional control, to the faculty employment tabulations. As before, it is separated into side-by-side public and private charts for ease of comparison, and for-profit institutions are not included. Full counts for all institution types are in appendix tables 8.1-8.3.

Employment of contingent faculty members predominates at associate's degree colleges in both the public and private sectors. At public community colleges, the contingent (primarily parttime) proportion rose from 78 to 82 percent over the period. The level of contingency in private associate's degree colleges was even higher, although we must note again that there are relatively few colleges in that sector. In the baccalaureate/small master's category, private institutions again consistently employed a larger proportion of contingent faculty, although the pace of growth in contingency was slightly greater at public (14 percentage point growth) than private (12 percentage point growth) institutions.

In both the master's/doctoral and research university categories, we see that the aforementioned shift to majority contingent employment occurred in the public sector—where the institutions also tend to be larger—while private universities were already employing a majority of contingent faculty in 1995. Public master's and doctoral universities went from 40 percent contingent faculty in 1995 to 59 percent in 2019, while the contingent proportion rose from 59 to 78 percent at private institutions in that




Figure 11. Contingent Employment among Faculty, by Institutional Category and Control, 1995–2019

category over the same period. At public research universities, 40 percent of faculty were employed in contingent appointments in 1995 and the proportion grew to 53 percent in 2019, while the private research universities were already at 50 percent contingent faculty in 1995 and increased contingent employment somewhat more slowly to 58 percent in 2019.

The trends shown in this section limited to faculty alone are more dramatic than those for instructional staff in the previous section, given that graduate student employees formed an essentially constant proportion of the total instructional staff. The dramatic shift from tenure-line to contingent faculty employment that has captured our attention in the last two decades is seen here to have been primarily a phenomenon of public master's/doctoral and research universities, which also employ the largest numbers of faculty. Part-time faculty appointments have long predominated in community colleges and contingent appointments formed the majority of the faculty in baccalaureate colleges and small master's universities throughout. This section, like the one that precedes it, demonstrates the importance of disaggregating academic employment status analysis by institutional type.

Conclusion

Although the "seismic shift"⁸ toward contingency in academic employment has been well documented for close to three decades, this report again shows the importance of examining the details of the long-term trend. The situation differs by institution type, the change in employment has not been equivalent for specific employment statuses, and the trend has not been uniform across time. The primary purpose of this report is to make important data available and accessible, so I have included only a minimum of analysis. I am making the data files used to compile this report available through the CSAL website, to encourage others to make use of the data to explore further questions regarding academic employment.

In a time of global health pandemic and economic recession, I even ask myself why a report on trends in academic employment is worth compiling. Yet as I write, 2021 election results have just been announced and serve as vet another reminder that the sometimes-violent reaction against expertise, science, and efforts to create a more just and inclusive society, exemplified by the Trump presidency and the cataclysmic events of 2020, has not faded into history. The recent attacks on critical race theory are but the latest example of the longstanding resistance to academic and activist efforts to unearth and disseminate a true accounting of American history and society. And who will continue that search for truth in the face of such attacks, if American colleges and universities continue to be characterized by the "gig" employment practices that have transformed other sectors of our labor force? (Kezar et al. 2019)

A data report alone will not stop attempts to silence those who seek the truth, but I offer it as one more tool in that ongoing search and struggle. Use it for good.

A Note on the Data

Most terms used in this report are drawn from the original data sources. The following terms are specific to this tabulation:

Instructional Staff. Includes all fulland part-time faculty members and graduate student employees.

Graduate Student Employees.

Individuals included in this category are only those who are reported in the employment survey under the label "graduate assistants" or "instruction/research assistants." Defined as part-time employees beginning in the mid-1980s.

Faculty. Includes all full- and part-time faculty members.

Contingent. Includes the following employment categories, as appropriate for the specific table: full-time non-tenuretrack faculty members, part-time faculty members, and graduate student employees.

All of the totals and percentages presented in the report are drawn from what is essentially a census of the population of higher education institutions, so no tests of statistical significance or confidence intervals are necessary.

Data source citations

With regard to the sources for data, this report can be divided into two sections: the published historical trend going back to 1975 and 1976, and the original tabulations beginning with fall 2011. All data are drawn from the US Department of Education, National Center for Education Statistics, Integrated Postsecondary Education Data System (IPEDS), "Fall Staff" component. (Data for 1975 and 1976 were from the predecessor data collection, the Higher Education General Information Survey [HEGIS].) IPEDS is a comprehensive census of all employees in higher education, as well as other institutional data components. Because institutions are mandated to provide accurate data for IPEDS in order to maintain eligibility for federal funding, IPEDS represents the most comprehensive source of data available.

Prior to 2002, the Fall Staff collection was the only comprehensive source for data on instructional staff employment status, and was completed in odd-numbered years. Beginning with 2002, IPEDS included a new Employees by Assigned Position (EAP) component. The EAP and Fall Staff components differ in the institutions included, so in order to maintain continuity for the historical trend analysis, only Fall Staff figures for odd-numbered years are included here.

Published historical trend data

The historical data used to produce the figures and tables in this report were compiled from published sources wherever possible, and the table below provides specific sources. All publications referenced below are from the US Department of Education, National Center for Education Statistics (https://nces.ed.gov/pubsearch/getpubca ts.asp?sid=010). Data for years between 1975-76 and 1989, as well as 1991 and 1997, were not available.

Original data tabulations

As noted above, the data for years beginning with 2011 in this report are drawn from IPEDS, specifically from the "Fall Staff" section of what is now the Human Resources component. The analysis was completed on raw data files downloaded from the IPEDS "Use the Data" page

(https://nces.ed.gov/ipeds/use-the-data). The data are compiled for all degreegranting institutions that reported employing instructional staff in each respective year. (The institution count in a given year may include a few that are in the data file but reported zero faculty members.) The institutional records selected for the tabulations are those listed as degree-granting and participating in federal Title IV financial aid programs. (The use of the Title IV criterion is typical in NCES published tabulations, and serves as a proxy for institutional accreditation.) Selection of institutional records is based on data from the IPEDS Institutional Characteristics component, specifically the header (HD) records file.

The tabulations of employment status by institutional category and control for all four time points (1995, 2005, 2015, 2019) were also created using the original IPEDS data files.

Counts of staff members are reported by each institution in the aggregate according to the reporting categories established by IPEDS. That means individuals, especially those faculty members employed parttime, may be double counted.

The IPEDS data do not actually use the term "faculty." Instead, they denote "employees whose primary responsibility is instruction, research, and/or public service," or words to that effect. Depending on the source file, counts may be split by these various "responsibilities." I have utilized the figure labeled for all of these functions combined wherever possible.

For the categorization of faculty positions as "tenure-line" (tenured or tenure-track) or "contingent," I have included all parttime positions in that employment status and in the broader contingent category. IPEDS does enable reporting of part-time tenured and tenure-track positions. According to a tabulation in the most recent AAUP report, these "part-time tenure-line" positions make up about 0.6 percent of the total faculty (AAUP 2021: table F, p. 16, my calculations). The positions are included as contingent in this report, whereas they would be counted as tenure-line in the AAUP categorization.

Report figures and tables that are broken out by "institutional category" utilize the Carnegie basic classification variable available in the IPEDS "header" (Institutional Characteristics) file for the given year. I have adapted the Carnegie basic classification into four categories: Associate's Colleges, Baccalaureate Colleges and Small Master's Universities, Larger Master's and Doctoral Universities, and Research Universities.⁹ Some of the appendix tables provide breakouts for all four categories.
