CALL FROM JO AND TOMMY TO WISH USA HAPPY NEW YEAR! CALLS FROM MARJORIE AND GINGER TOO. CAROL WASHED AND IRONED. I MADE A FIRE IN THE WOOD STOVE TO WARM UP THE LAUNDRY ROOM AND TO DRY THE CLOTHES

1/2 MARJORIE WAS WITH US FOR BREAKFAST. CAROL WENT TO THE HAIRDRESSER IN THE AM. AFTER CAROL RETURNED, I TOOK THE CAR AND WENT TO ENGLEWOOD TO GET PRINTS, MAIL A LETTER TO DR FEAD TO FET ITEMS FROM THE GROCERY STORE AND TO SEE ABOUT CERTAIN SAW PRICES (\$169.95 FOR ONE WITH A 14" BLADE). IN THE AFTERNOON, I WENT TO LEWANS TO TALK TO KAES TO GET MY COMMODORE COMPUTER FIXED AND TO GET A NEW COMPUTER. I GOT A TI 55 COMPUTER. SUNSHINE TODAY, SOMETIMES INTERRUPTED BY CLOUDS.

1/3 MARJORIE WAS WITH US FOR BREAKFAST. CAROL CLEANED KITCHEN CUPBOARDS. I WORKED WITH THE TI COMPUTER AND ADDED TO THE TEXT ON MY PROPOSED PAPER ON RETURN FLOW. SUN SHONE MOST OF THE DAY.

1/4 MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I WENT TO ENGLEWOOD IN THE MORNING FOR GROCERIES. I LEFT OUT MANTEL CLOCK WITH ANDERS FOR REPAIRS (\$42.00). IN THE AFTERNOON, CAROL AND I TOOK CHECKS TO THE BANK. I WORKED ON THE RETURN FLOW PAPER.

1/5 MARJORIE WAS WITH US FOR BREAKFAST. COLD LAST NIGHT AND THIS MORNING. SOME POWDER SNOW FELL. I SWEEPED THE FRONT WALKS AND MAILED LETTERS. AFTERNOON CLEAR AND SUNNY.

1/6 WARMER TODAY. I GOT OUT AND GOT A HAIRCUT. I PACKAGED UP TWO PAIRS OF PLACARDS TO SEND TO CHARLIE KONG. CAROL MADE AN ICEBOX CAKE FOR CHARLES (BIRTHDAY - 9.00)

1/7 CHARLES, GINGER, CHASE, MARGO AND MARJORIE CAME SHORTLY BEFORE NOON. WE HAD A BIRTHDAY SUNDAY DINNER FOR CHARLES. THEY LEFT ABOUT 2:00 PM AND I TALKED ABOUT GETTING WOOD. A LETTER CAME FROM THE US ARMY MILITARY HISTORY INSTITUTE. I SEPNT MOST OF THE AFTERNOON FILLING OUT FORMS. CALM AND SUNNY TODAY.

1/8 MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I DISPOSED OF TRASH. CAROL DID THE WASH AND IRONED. I BUILT A FIRE IN THE WOODSTOVE TO WARM UP THE WORK ROOM AND TO DRY THE CLOTHES HUNG ON THE LINE, IN THE EVENING, FRANK SARLES AND I WENT IN MY CAR TO AN ASCE MEETING AT THE RAMADA INN AT 1150 E COLFAX. I HAD MY HAT, MY OVERCOAT AND MY GLOVES STOLEN. FRANK LOST AN OVERCOAT AND A HAT. ANOTHER MAN REPORTED STOLEN OVERCOAT.

1/9 MARJORIE WAS WITH US FOR BREAKFAST. WE SANG "HAPPY BIRTHDAY" TO CHARLES OVER THE PHONE. CAROL AND I WENT TO WARDS IN THE MORNING WHERE I GOT A COAT TO REPLACE THE ONE STOLEN YESTERDAY AND A PAIR OF HIKING SHOES. AFTER DINNER, WE WENT TO THE SOUTH DENVER POST OFFICE TO MAIL THE PLACARDS TO CHARLIE KING. I WENT TO THE LOCAL GROCERY FOR PANCAKE FLOUR AND ON THE WAY, GOT A HAMBURGER FOR CAROL'S SUPPER. GINGER CAME WHILE WE WERE OUT, TO LEAVE PICTURES.

1/10 MARJORIE WAS WITH US FOR BREAKFAST. CAROL BROUGHT HER RECORD BOOKS UP-TO-DATE. CAROL GOT MY CLOTHES READY AND FIXED A LUNCH SO I COULD GO TO BARRACKS 3149 VWWI MEETING AT NOON. ROWE BROUGHT A PAIR OF PLACARDS AND SARLES BROUGHT ME AND THE SIGNS HOME, IN THE EVENING, I PICKED UP FRANK SARLES AND WE WENT TO THE UNITED VETERANS COUNCIL MEETING. I GOT HOME AROUND 10:00 PM

1/11 MARJORIE WAS WITH US FOR BREAKFAST. CAROL WENT TO THE HAIRDRESSER IN THE AM. A CALL FROM THE RAMADA INN TO SAY THAT OUR COATS WERE THERE AND TO EXPLAIN THAT AN EMPLOYEE SEEING THEM ON THE COAT RACK AND FEARING THE WOULD BE STOLEN, TOOK CARE OF THEM BUT FORGOT TO TELL ANYONE ELSE WHAT HE HAD DONE. FRANK SARLES CAME BY AND WE WENT TO THE INN AND RECOVERED OUR COATS THE MAN AT THE DESK TOLD US THEY WERE FOUND IN THE BAR. THIS SOUNDS LIKE A COCK AND BULLS STORY COOKED UP TO MAKE IT APPEAR WE HAD HUNG THEM THERE, GOT TOO DRUNK, AND LEFT WITHOUT THEM. WE WERE NOT IN THE BAR. I CALLED THE POLICE TO REPORT THAT I HAD MY HAT, COAT AND GLOVES.

1/13 CAROL AND I WERE HER[E] ALOEN ALL DAY. CAROL DID TYPING FOR ME AND PAID BILLS. I WENT TO THE MAILBOX AND MAILED THEM

1/14 MARJORIE CAME OVER IN THE TIME FOR SUNDAY DINNER AND LEFT ABOUT SUPPERTIME. CAROL AND I READ AND RESTED

1/15 MARJORIE WAS WITH US FOR BREAKFAST AND DINNER. CAROL WASHED AND IRONED. CAROL AND I DISPOSED OF TRASH. I MADE A FIRE IN THE WOOD STOVE TO WARM UP THE WASHROOM. I PUT ASHES ON THE SLIPPER SPOTS IN FRONT WALK. I STUDIED INSTRUCTION BOOK FOR MY NEW COMPUTER TI-55

1/16 MARJORIE WAS WITH US FOR BREAKFAST. CAROL FINISHED IRONING AND MADE SOME JELLO FOR TOMORROW. I MADE A TELEPHONE CALL TO FEAD ABOUT SHORT COURSE COST AND DELMANZO'S CASE, I WENT TO LEWAN ASSOC. AND FOUGHT A TI-79 COMPUTER AND A PRINTER. IN THE EVENING I WENT TO THE LOCAL GROCERY STORE FOR GROCERIES AND PICKED UP 2 SANDWICHES FOR DINNER. SUNNY ALL DAY.

1/17 MARJORIE WAS WITH US FOR BREAKFAST, CAROL WROTE LETTERS AND PREPARED MEALS. I FINISHED A CHECK COMPUTATION ON THE TRIANGULAR CASES AND READ FROM NEW PROGRAMMING MANUAL. CLEAR AND SUNNY TODAY.

1/18 MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I WENT TO ENGLEWOOD WHILE CAROL GOT GROCERIES. I PUT MY ROYALTY CHECK FOR \$94.56 IN THE BANK, LEFT MY "BENEDICT" ALARM WATCH WITH ANDERS, TO BE REPAIRED AND MADE SMALL PURCHASES. AFTER RETURNING HOME, I MAILED LETTERS AND SWEPT AND SHOVELLED WATER AND ICE OFF THE SIDEWALK. LATER, I PUT ASHES ON THE ICE.

1/19 MARJORIE WAS WITH US FOR BREAKFAST. I WENT IN MY CAR TO ENGLEWOOD TO GET WATCHES FIXED AT LOFTUS JEWELERS TO GET COPIES AND TO THE HARDWARE STORE TO GET THE GROUNDED CABLE. I WENT TO KROONENBERG TO GET SAND AND TO THE AUTO SHOP TO GET A STEERING WHEEL COVER, NO LUCK. IN THE EVENING I DID SOME COMPUTING. I TALKED TO F. BELL ON THE PHONE.

1/20 MARJORIE WAS WITH US FOR BREAKFAST AND SUPPER. WENT TO ENGLEWOOD ON THE BUS TO GET SOME COPIES I WANTED AND MAILED LETTERS. GINGER CAME ABOUT 4:00 PM TO LEAVE CHASE AND MARGO WITH US TO SPEND THE NIGHT.

1/21 CHARLES, GINGER AND MARJORIE CAME. CHASE AND MARGO HAD SPENT THE NIGHT AND WERE WITH US, ALSO. CAROL PREPARED A BIRTHDAY DINNER (SUNDAY) FOR ME. THERE WAS A CAKE WITH ONE CANDLE. CHARLES AND FAMILY GAVE ME A SHIRT, MARJORIE GAVE ME PAJAMAS. WHEN THEY LEFT, CHASE AND MARGO WENT WITH CHARLES AND GINGER. CHARLES' PLACS TO BUY A MCCULLOCH

CHAINSAW. I PRACTICED ON MY TI-55 COMPUTER IN THE EVENING. WENT TO "JACK-IN-THE-BOX" FOR SANDWICHES FOR SUPPER.

1/22 (MY BIRTHDAY - 83RD. MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I DISPOSED OF TRASH, CAROL DID THE WASH. I WENT TO THE LOCAL GROCERY FOR POTATOES AND CAROL MADE A STEW. ON THE WAY, I PICKED UP SOME SANDWICHES FOR THE NOON MEAL. SNOW BEGAN ABOUT NOON. I SHOVELLED WALKS ABOUT 1:30 PM. FLOYD COLLINS BROUGHT OVER COOKIES (NEIGHBOR). GINGER AND FAMILY SANG HAPPY BIRTHDAY TO ME OVER THE PHONE. GUY COCAGNE- (NEIGHBOR) AND CAROL SHOVELLED OUR WALKS AGAIN.

1/23 MARJORIE WAS WITH US FOR BREAKFAST. I WENT TO THE 401 BUILDING FOR A CLASS IN COMPUTER PROGRAMMING. CAROL FINISHED THE IRONING AND WROTE LETTERS. IN THE AFTERNOON I SHOVELLED THE BACK WALKS AND TRIED TO GET GROUNDED PLUGS HOOKED UP FOR USE WITH MY NEW TI-59 COMPUTER THE PLUGS WOULD NOT GO TOGETHER. JEANING CAME OVER IN THE EVENING FOR SOME HELP WITH ALGEBRA PROBLEMS. CAROL AND I HELPED.

1/24 MARJORIE WAS WITH US FOR BREAKFAST. CAROL PAID BILLS AND I TOOK THEM OVER AND MAILED THEM. PHONE CALL CAME FROM FLORIDA ABOUT USE OF A FORMULA FROM THE "TRANSIENT GROUNDWATER HYDRAULICS" MADE PHONE CALLS TO AN ELECTRICIAN HE WILL COME TOMORROW TO MOUNT THE 3 WAY PLUGS I NEED. PHOTOGRAPHER WILL SEND ORDER FORM. CHARLES CALLED ABOUT A CHAINSAW NUMBER

1/25 ROGER MAUPIN AND HELPER OF THE MAUPIN ELECTRICAL COMPANY CAME IN THE MORNING AND INSTALLED THE GROUND PLUGS I NEEDED. THEY TESTED THEM TO INSURE I HAD A GROUND. SNOW TODAY- I SWEEPED THE WALKS IN THE MORNING AND GUY COCAGNE SHOVELLED THEM AT 5:00 PM, I PUT SAND AND SALT ON ICY SPOTS IN THE MORNING AND MORE SALT AFTER 5:00 PM. I PUT UP THE SEWING MACHINE AND CAROL FIXED TWO BLOUSES FOR MARJORIE. CAROL MOPPED THE FLOOR IN THE STUDY ROOM. CAROL ORDERED SUITS FOR ME. MARJORIE WAS HERE FOR BREAKFAST. I WENT TO NIELSEN'S TO GET A NEW DESK PAD.

1/26 CAROL SWEEPED OUT TO THE CURB BEFORE 7:00 AM. MARJORIE CAME FOR BREAKFAST. ABOUT 8:00 AM, I SWEEPED THE REST OF THE FRONT WALK. CAROL FIXED KIM'S COAT AND WASHED HER HAIR. I TRIED TO USE MY NEW TI-59 COMPUTER BUT HAD NO POWER. BERG CAME FROM MAUPIN ELECTRIC AND DISCOVERED THAT DUAL SWITCH, WHICH GIVES ROOM LIGHT CONTROL FROM UPSTAIRS OR DOWNSTAIRS WAS THE CAUSE. 1/28 COLD AND LIGHT SNOW. CAROL SWEEPED THE WALK OUT TO THE STREET, I USED THE SNOW SHOVEL LATER. MARJORIE WAS WITH US FOR THE SUNDAY NOON MEAL.

I CALLED DR BARNES AT FT COLLINS TO ANSWER QUESTIONS ASKED IN HIS RECENT LETTER. I CALLED CHARLES IN THE EVENING TO TELL HIM I HAD A SMALL PART OF HIS CHAINSAW. HE WILL GET IT SUNDAY. I DID MORE COMPUTING WITH THE TI-59. I SWEEPED THE WALKS AND APPLIED SALT AND SAND

1/30 MARJORIE WAS WITH US FOR BREAKFAST. CAROL FINISHED THE IRONING. I SPENT THE MORNING PREPARING A LETTER TO DR BARNES. I MAILED IT IN TIME TO CATCH THE 11:40 AM PICK UP. I INSPECTED THE FRONT WALK ABOUT 8:00 PM TO SEE IF IT NEEDED MORE SALT OR SAND. IT NEEDED NEITHER. I WORKED ON THE COMPUTATIONS FOR THE RETURN FLOW PAPER.

1/31 MARJORIE WAS WITH US FOR BREAKFAST. TEMPERATURE IS +1[degree Fahrenheit] THIS MORNING. CAROL TOOK CARE OF OLD MAGAZINES. I WROTE LETTERS TO KERRY, JEAN, TRACY AND KIRK (BILL'S FAMILY) AND MAILED THEM. IN THE LATE AFTERNOON, I PUT SOME SAND ON AN ICY SPOT ON OUR FRONT WALK.

2/2 MARJORIE WAS WITH US FOR BREAKFAST. CAROL WROTE LETTERS, I MAILED THEM. I WENT TO LEWANS TO GET A NEW ROLL OF COMPUTER TAPE. THEY DID NOT HAVE ANY. I SANDED ICY SPOTS ON MY WALK AGAIN TONIGHT. SUNNY TODAY AND YESTERDAY. I MAILED A REQUESTED REPORT TO THE ARMY

2/15 USBR RETIREES LUNCHEON

2/4 MARJORIE, GINGER, CHASE AND MARGO CAME AND HAD SUNDAY DINNER WITH US. CHARLES AND FAMILY LEFT ABOUT 2:00 PM. MARJORIE LEFT LATER, BUT BEFORE SUPPERTIME. I SANDED THE FRONT WALKS TWICE TODAY. IN THE BACKYARD, I MADE A DAM OF SNOW AND SHOVELLED THE WATER BEHIND IT TO PREVENT THE GARAGE DOOR FROM FREEZING SHUT. OUR SIDE GATE HAS BEEN FROZEN SHUT FOR WEEKS, CHARLES TOOK THE BOOK "TO THE FAR BLUE MOUNTAINS" WITH HIM TO READ. CAROL PREPARED THE DINNER.

2/5 MARJORIE WAS WITH US FOR BREAKFAST. CAROL WASHED AND IRONED. CAROL AND I DISPOSED OF TRASH ON THE MORNING. CAROL LENGTHENED A PAIR OF SLACKS FOR MARJORIE. I GOT A HAIRCUT. I SHOVELLED WATER AWAY FROM THE GARAGE. I SWEEPED WATER FROM THE FRONT WALK AND PUT SAND ON IT IN THE EVENING. CAROL FIXED UP MY SUIT SO I COULD GO TO FT COLLINS IN THE MORNING

I FREED THE SIDE GATE OF ICE SO WE COULD GET THROUGH AND SWEEPED WATER OFF OF FRONT WALK. 2/8 MARJORIE WAS WITH US FOR BREAKFAST. CAROL SHOVELLED THE FRONT WALK IN THE MORNING, (THERE WAS A SNOW LAST NIGHT) CAROL WROTE LETTERS AND I MAILED THEM. I USED SALT AND SAND ON THE ICY PLACES ON FRONT WALK.

2/9 MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I WENT TO ENGLEWOOD FOR GROCERIES. WHILE THERE, I GOT PRINTS AND SMALL ITEMS AND MAILED LETTERS. WE ALSO BANKED CHECKS. (SUN SHINING TODAY). IN THE EVENING I MADE COMPUTATIONS ON THE RETURN FLOW CASES. ABOUT 9:00 PM I WENT OUT TO LOK AT THE WALKS. ALTHOUGH THE AIR TEMPERATURE WAS STILL 40[degrees Fahrenheit]. 2/11 MARJORIE WAS WITH US FOR THE NOON MEAL AND FOR SUPPER I SWEEPED WATER OFF THE FRONT AND BACK WALKS. PARTLY CLOUDY AND WARM TODAY. AT ABOUT 8:00 PM ICE HAD FORMED ON THE FRONT WALKS AGAIN WITH AIR TEMPERATURE AT 40[degrees Fahrenheit]. I SANDED THE SMALL ICY SPOTS. I HAD PREVIOUSLY SWEEPED OFF MOST OF THE WATER.

2/12 MARJORIE WAS WITH US FOR BREAKFAST. CAROL AND I DISPOSED OF TRASH. I BUILT A FIRE IN THE STOVE TO TAKE THE CHILL OFF THE WASHROOM. CAROL WASHED, IRONED AND MENDED. I MADE A CALL TO DR BARNES AT FT COLLINS. THE VALUES HE SENT LOOK GOOD. IN THE EVENING I STUDIED SOLUTIONS OF THE LEGENDRE DIFFERENTIAL EQUATION WHICH WILL COME TO ZERO AT $U = -(\frac{1}{2})$

2/13 MARJORIE WAS WITH US FOR BREAKFAST. CAROL WENT TO THE HAIRDRESSER IN THE MORNING AND FINISHED THE IRONING IN THE AFTERNOON. I CALLED VVWI VETERANS. I MAILED LETTERS.
