



Dear Mike,

I am again applying for the FLEP-3 program for our tree farm. I am applying for 2 acres with the objective of Forest Stand Improvement – Thinning. As you know this will also help the Forest Stand Improvement – Fuel Break by getting all of that dead wood off the mountain.

My intent is to work 1 acre on the right side of the road and 1 acre on the left side of the road. This is a continuation on the work we did the last few years.

The purpose and goals would continue along the same lines as always. I have included them on a separate sheet. These are the objectives established at the beginning of our Forest Stewardship Plan.

The resources will mostly be our family members.

The equipment used will be 2 trucks, 2 trailers, 4 chainsaws and 1 wood splitter. The time line will be from June 1 to September 15, 2007.

The intent will be to cut and limb the required green timber and leave on forest floor until next year. We will block and haul out the dead timber and last year's green timber cut.
