Emerald Ash Borer (EAB) Update

EAB was positively identified in the City of Boulder in September of 2013. Since that first EAB discovery, the Colorado Department of Agriculture has established a quarantine around Boulder County, the City of Erie, several landfills, and wood sorting yards to restrict the movement of ash wood (*Fraxinus* species). The wood can only be moved out of the quarantined area if it has undergone proper treatment (i.e., chipping, heat treatment, composting, fumigation). A delimited survey was conducted in 38 grids (each 1 square mile) within the City of Boulder. In each grid, 2 branches from each of 10 ash trees were sampled. The survey is 100% complete and 5 of the 38 grids had positive EAB detections.

APHIS, CSU Extension, Colorado State Forest Service, and University of Colorado – Boulder, continues to meet and collaborate on information, strategies, and control efforts.
