**Rural Business Development Grant Available: USDA Seeks Applications to Advance Economic Development and Create Jobs for People in Rural America**

USDA Rural Development is accepting applications to advance economic development and create jobs for people in rural America through the [Rural Business Development Grant](#) program. The program supports business opportunities or business enterprise projects in rural communities.

Organizations eligible to receive funding include:

- Rural towns
- Communities
- State agencies
- Authorities
- Nonprofits
- Federally recognized Tribes
- Public colleges
- Non-profit cooperatives

## Rural Energy for America Program (REAP) Funding Available

USDA Rural Development has grant funding available to help agricultural producers with renewable energy or energy efficiency improvements through our Rural Energy for America Program.

Grant funds for up to 50% of the total project costs are currently available for installation of renewable energy systems and energy efficiency improvements for agricultural producers and rural small businesses.

Applications for the [Rural Energy for America](#) are accepted anytime, with quarterly funding competition deadlines through September 30, 2024.

Upcoming deadlines are:

- March 31, 2024
- June 30, 2024
- September 30, 2024

Agricultural producers with at least 50% of their gross income coming from agricultural operations can apply for REAP; they can be located in rural or nonrural areas. Small businesses that are located in an eligible rural area are also eligible to apply.

REAP Renewable Energy System (RES) funds can be used for systems such as:

- Small and large solar or wind generation
- Geothermal for electric generation or direct use
- Hydropower below 30 megawatts
- Biomass (for example: biodiesel and ethanol, anaerobic digesters, and solid fuels)

REAP Energy Efficiency Improvement (EEI) funds can be used to buy, build, and install EEI such as:

- Electric, solar, or gravity pumps for sprinkler pivots
- Switching from a diesel to an electric irrigation motor
- Lighting, Insulation, Doors, Windows, Cooling or Refrigeration units
- High-efficiency heating, ventilation, and air conditioning systems (HVAC)

## Rural Innovation Stronger Economy Grants Available to Create High-Wage Jobs and New Businesses in Underserved Rural Communities

The Rural Innovation Stronger Economy (RISE) program encourages regional, innovation-driven approaches to economic development by funding job accelerator partnerships in low-income and underserved rural communities.

For fiscal year 2024, the program is making approximately \$2 million available to partnerships of local governments, investors, industry, institutions of higher education, and other public and private entities in rural areas. The funding may be used to support innovation centers and job accelerator programs that improve the ability of distressed rural communities to create high-wage jobs, form new businesses, and identify and maximize local assets.

The deadline to submit applications is 11:59 p.m. Eastern Time, April 1, 2024. Applications must be submitted through [Grants.gov](#). Potential applicants may submit a concept proposal for review by the agency to Grants.gov no later than 4:30 p.m. local time Feb. 1, 2024.

The minimum award amount per grant is \$500,000. The maximum award amount per grant is \$2 million. [For additional information, see page 43 of the Jan. 2, 2024, Federal Register.](#)

## Community Facilities Loan & Grant Program

The USDA Community Facilities program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings.

This infrastructure funding will expand access to health care, education, and public safety while spurring community development and building sound infrastructure for people living in rural communities.

More than 100 types of projects are eligible for Community Facilities funding. Eligible applicants include municipalities, public bodies, nonprofit organizations, and federally recognized Native American tribes. Projects must be in rural areas with a population of 20,000 or less.

### The Economic Contribution of River-Based Recreation in the Little Yampa Canyon, Colorado

#### Key Findings

- River-based recreation on the Yampa River contributes \$70,373.68 in estimated output to Craig, CO.
- A proposed 660-acre public land acquisition would provide an additional \$109,497.02 in output.
- Increasing recreational amenities and quality will provide a positive impact to visitation, increasing expenditures by up to 30.4% per quality improvement.

### REDI@CSU Awarded EDA Grant to Establish University Center

#### Key Findings

- REDI and its partners were awarded a \$750,000 grant to support economic development in Colorado.
- The grant will establish an EDA University Center (UC) at Colorado State University (CSU).
- The UC will conduct research, provide technical assistance, and share data for equitable development.

## September 2023 REDI report How can a Tourism Support Fee facilitate Economic Diversification in Clear Creek County?

### Key Findings

- Based on a 1% tax rate, a tourism support fee can potentially generate over \$1million in annual tax revenue.
- To foster economic diversification, we recommend that Clear Creek County establish a loan fund from a tourism support fee to encourage entrepreneurship.
- Clear Creek County's natural amenities have the potential to attract highly skilled remote workers. However, it is crucial for the county to address rising housing costs.
