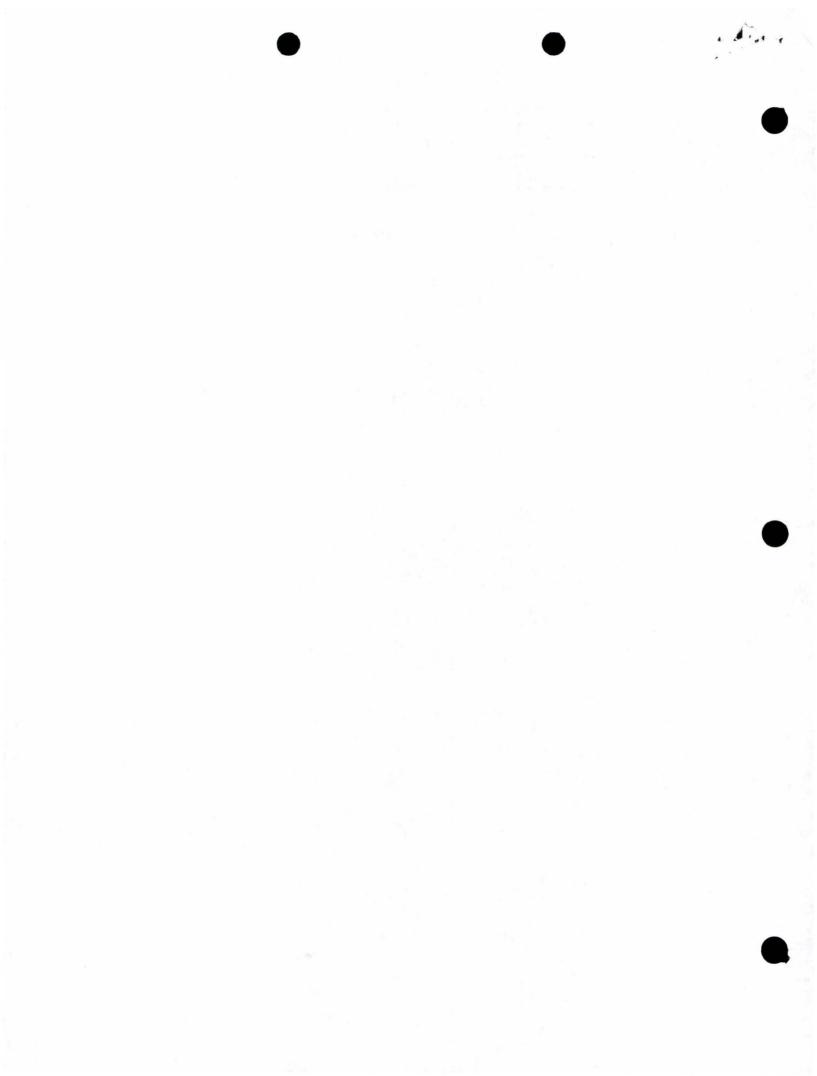

Please find attached the final reimbursement report and the attached forms for reimbursement for the Larimer County Natural Resources Department Hermit Park Open Space Fuels Treatment and Forest Stewardship Project (WUI Grant Project #530952).

Project Summary:

During the months of September and October, 2008, 59.5 acres were treated within the project area at Hermit Park Open Space. During August and September, 2009 and additional 50 acres were treated in an agreed upon additional and expanded treatment area. Trees were mechanically removed by hand crews to reduce stand densities to an average basal area of 50 and patch cuts created openings in unnaturally dense stands of ponderosa that were infected with dwarf mistletoe. Trees were cut into firewood lengths and currently within the 50-acre area are being removed by volunteers as well as limbs being stacked for future burning.

Grant dollars were used to contract the Larimer County Emergency Services Mitigation Crew to conduct thinning efforts. 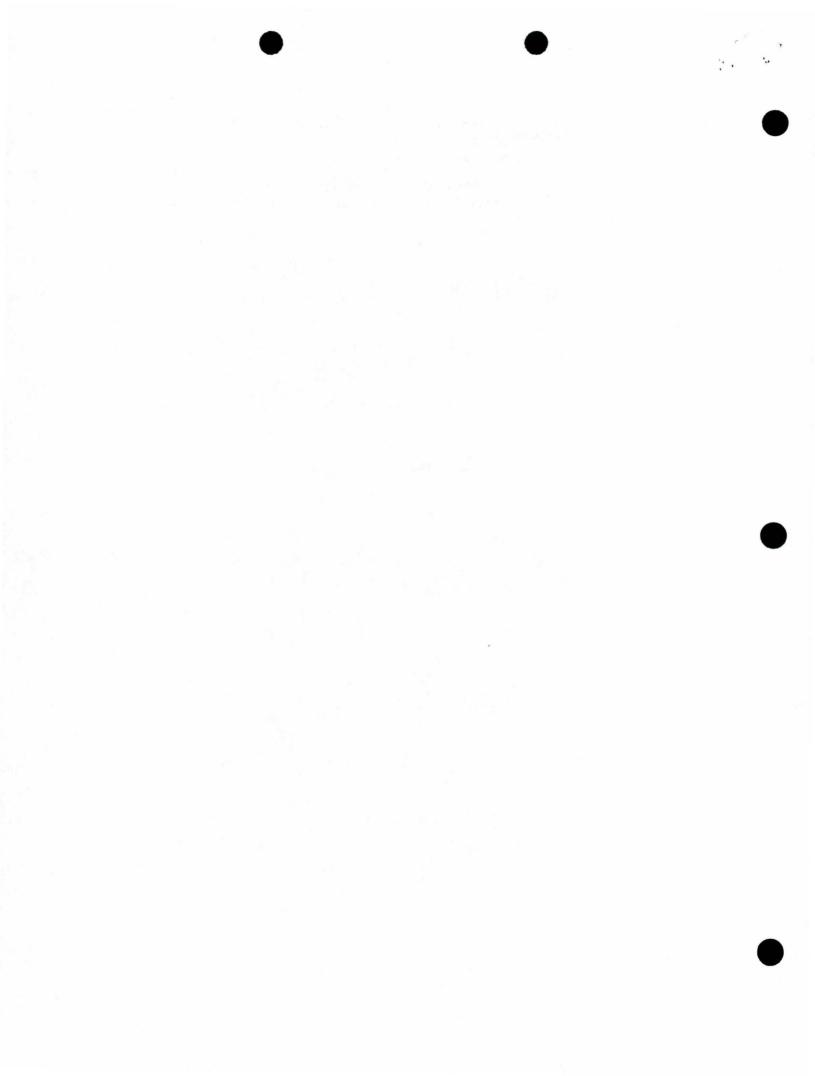

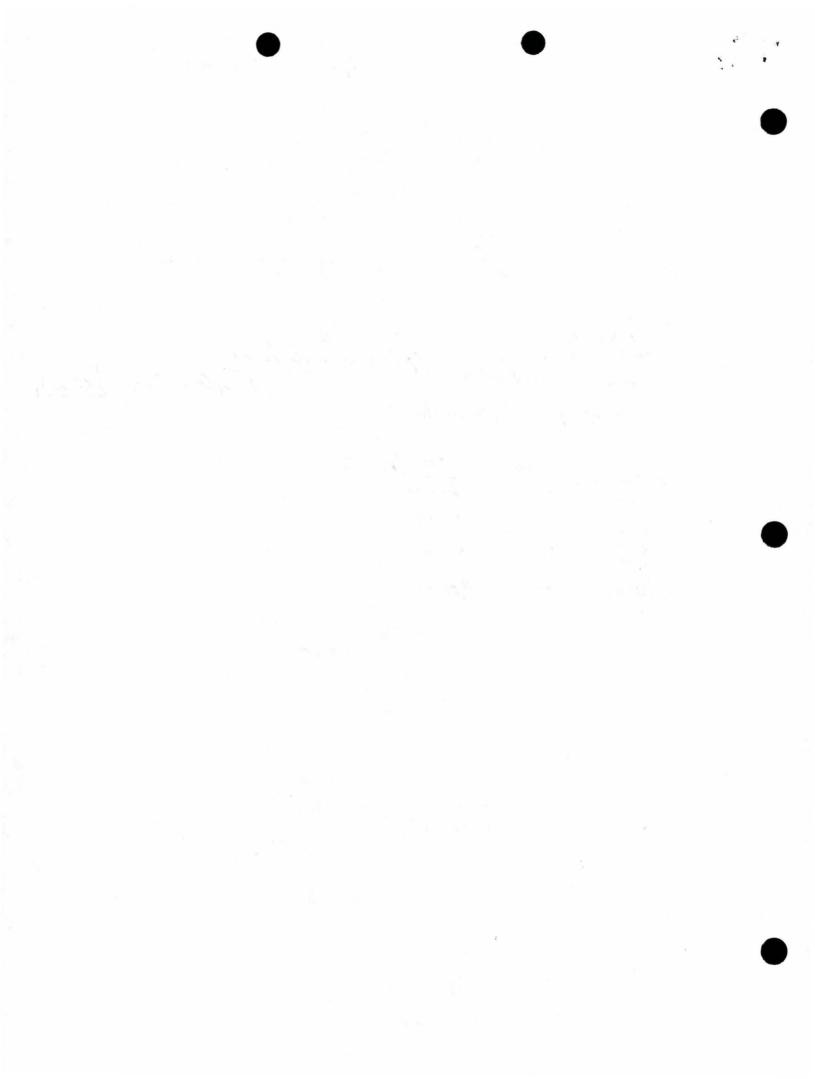

Project Summary:

The Hermit Park Open Space Defensible Space/Fuels Reduction Project was implemented in August 2007 by the Larimer County Emergency Services Wildfire Mitigation crew. Structures were evaluated for defensible space and defensible space was created or expanded around existing cabins. Trees were removed by hand crews by means of mechanical thinning with chainsaws. Trees were cut into firewood lengths for future public use at the cabins for campfires and branches and slash were stacked for winter burning or removal.

Hermit Park Open Space (HPOS) is owned and managed by Larimer County Parks and Open Lands Department. Located in the Estes Valley, vegetation types on-site include montane forests and high meadow grasslands bisected by extensive wetland complexes. The montane forest ranges from open ponderosa pine stands at low elevations to mixed ponderosa pine/Douglas-fir at mid-elevations and finally to lodgepole pine at the highest elevations. The forests are broken up by pockets of aspen and open meadows and include a diverse array of native understory species including wax currant, mountain muhly, blue grama, alpine timothy, mountain brome, and others.

The open space has a number of developed recreational facilities and amenities including 15 camper cabins, 5 camping areas with a total of 75 campsites, 3 vault toilets, a 40-acre group picnic area with associated structures and two historic cabins. There is also a caretaker's house and several maintenance buildings. Additionally, several subdivisions and the Town of Estes park are immediately located to the west of the property.

HPOS consists of 1,362 acres, approximately 90% of which is forested predominately with mixed-stands of ponderosa pine, Douglas-fir, lodgepole pine, as well as representative limber pine and Rocky Mountain juniper. This project consists of fuel reduction by means of mechanical thinning by contracting Larimer County Mitigation Crew, it is anticipated that work would be completed in the summer months and burning of subsequent slash piles in the winter or when conditions allow. There is potential for chipping of slash on some accessible slopes. Larger trees will be bucked and removed for firewood as a management technique to prevent campers from collecting down wood or breaking branches off of living trees for campfires.

Thinning operations will focus on mountain pine beetle and dwarf mistletoe-infected trees, dog hair stands, poor growth form and deformed trees within the delineated treatment area, thus reducing the impact of a wildfire. 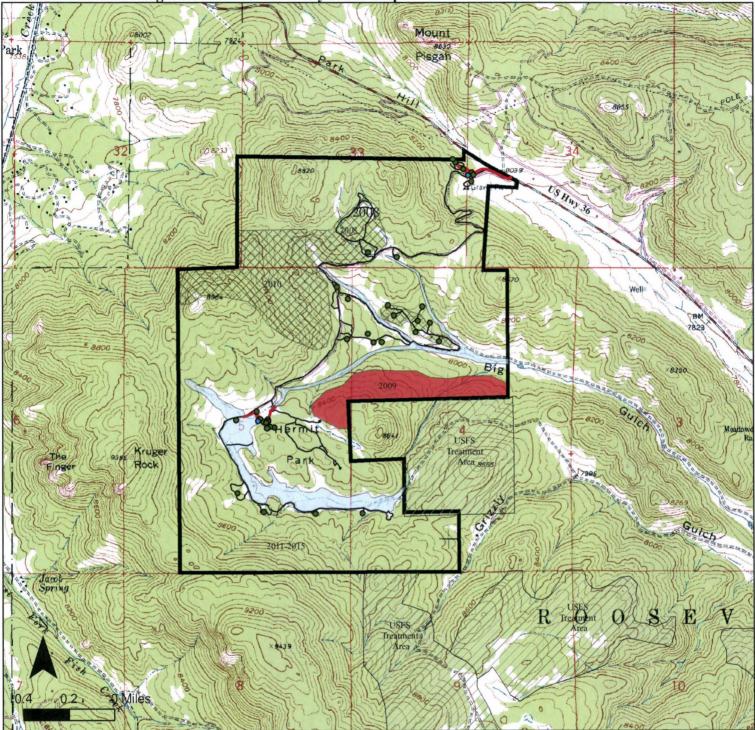
