
Bull Mountain State Trust Land

BULL MOUNTAIN - From Fort Collins take Hwy 287 north 22 miles to the Cherokee Park Rd. (Larimer County Road 80C), go approximately 35 miles west to the property.

STATE TRUST LANDS were given to the state by the federal government when Colorado was granted statehood in 1876. Revenues from rents, royalties and land sales go to benefit the state's K-12 public schools and several other smaller trusts. The trust lands total nearly 3 million surface acres and 4 million acres of subsurface mineral rights.

Since the trust lands are managed to generate revenue for public schools and to preserve long term productivity and value, the lands are not all open for public use.

Most of the state trust lands are leased to private parties, and access is controlled by those lessees.

In 1992 the State Land Board adopted a multi-use access policy, which means certain properties may be open to the public for wildlife related recreation.

The State Land Board and the Division of Wildlife have agreed to select about 500,000 acres of

The State Land Board and the Division of Wildlife have agreed to select about 500,000 acres of trust lands with the best wildlife values to be opened for public use over a 10-year period. The Division will pay for this opportunity, using hunting and fishing license fees. The Land Board will use that money to help finance public schools in Colorado.

WELCOME TO COLORADO'S STATE TRUST LANDS

The Colorado Division of Wildlife is proud to offer everyone who wants to participate in wildlife recreation the opportunity to enjoy the State Trust Lands Access program. This fall, the program will have opened more than 431,000 acres of State Trust lands for public access. The DOW pays just \$1 an acre a year in hunting and fishing license fees to the State Land Board for hunters, anglers and wildlife watchers to use these properties.

For many years, hunters and anglers have told us that access to lands for wildlife recreation is getting harder and harder to find. We've taken these concerns seriously and have made a commitment to provide more public access through our State Trust Lands program.

The State Trust Lands were given to the state of Colorado by the federal government at statehood in 1876. Current trust lands total nearly 3.2 million surface acres. Almost all of this land has been closed to the public in the past. Revenues from these leases go to benefit the state's K-12 public schools.

In 1993, the State Land Board and DOW entered into an agreement to lease about 500,000 acres of trust lands with the best wildlife values for public use over a 10-year period. At only five years into the program, we have nearly reached that goal. We hope to expand the program in the

What's New For 1997

More Properties Opened: This year, 30 new State Land Board properties, or 60,676 acres, will be open to public use. That brings the total State Trust lands open for wildlife recreation to 195, about 432,464 acres in all.

Youth Mentor Lands: This year, the DOW will open four State Trust lands for its Youth Mentor Program, making a total of 5 properties specifically for youths to hunt and fish. These properties are in Otero, Routt, Moffatt and Logan counties. Public access is limited to youth hunters and accompanying adults. See inside for details.

Volunteer Host Properties: To help serve the public better, some State Trust lands may have volunteer hosts who can provide information on boundaries, season dates and regulations. The volunteer also will ask you about your visit to help improve user satisfaction. The volunteer host program is expected to be expanded in the future.

Weed-Free Livestock Forage: Starting this year, only lifestock forage certified as weed-free will be permitted by recreationists on State Trust Lands.

Game Management Units: In response to public requests, we have added the GMUs for each property listed in this brochure. Once you have determined which property you're interested in, you can refer to the DOW's statewide GMU map and specific regulations for GMUs, which are found in the DOW's hunting season information brochures.

Three-Year Brochure: No additional State Trust Lands will be enrolled in the Access Program until the year 2000. Therefore this brochure will serve as a three-year publication. Please keep it on hand.

This brochure lists all of the State Trust Lands where people can hunt, fish and watch wildlife, including when the lands are open, how to find them, what species are there, facilities available and restrictions. You'll also find an order form so you can send away for maps of each property.

RULES FOR USING DOW PROPERTIES

These regulations are paraphrased so you can understand them easily. They are intended only as a guide. The official statutes and regulations that govern hunting and fishing in Colorado are available at DOW offices. The following activities are **prohibited** on all lands, waters, the frozen surface of waters, rights-of-way, buildings and other structures or devices under the control of the DOW:

- Entering or using an area when there are signs posted that prohibit entry, use or occupancy.
- Entering or using an area for commercial purposes or conducting land, water, oil, gas or mineral investigations, surveys or explorations.
- Operating a motorized or non-motorized vehicle except on publicly maintained roads or in designated camping or parking areas.
- Operating a motor vehicle above posted speed limits or more than 25 miles per hour where not posted.
- 5. Leaving a camp, pitched tent, shelter, motor vehicle or trailer unattended for more than 48 hours, or camping or parking a travel trailer or camper more than 14 days in any 45-day period.
 - 6. Building a permanent structure or plant vegetation. Only portable

blinds or tree stands and steps are allowed. No nails can be driven into trees. Man-made materials for blinds or tree stands must be removed within 10 days after the end of the season in which they are used.

7. Removing, changing or damaging buildings, water control devices, fences, gates, notices, signs, section markers, trees, shrubs, other vegetation or objects of archaeological, geological or historical value.

8. Littering or leaving fish, fish entrails, human excrement, waste water, containers, trash or toxic substance. It's also illegal to bring trash or toxic substances for disposal on a Division property and to dump trailer waste into a sanitary facility.

Building a fire without ways to prevent it from spreading or leaving a fire unattended.

Grazing livestock, except for horses, mules, llamas and burros used in wildlife recreation.

11. Letting dogs, cats or domestic pets run at large (not on a leash), except while hunting with dogs, training dogs for hunting or during Division-authorized field trials.

12. Possessing or using explosives, poisons, herbicides, insecticides or other pesticides.

13. Digging trenches, holes or pits.

14. Leaving boats, rafts or other floating craft beached, at anchor, moored or docked unattended overnight except in areas designated.

15. Fishing from Division-controlled boat ramps or boat docks when in conflict with boaters or as posted.

16. Snorkeling, scuba diving or spearfishing with a diving mask, swim fins, snorkel or air tanks, except in waters where swimming is permitted, when location is identified by a "divers' down flag" and when the scuba diver has a valid S.C.U.B.A. diver's certificate issued by a recognized S.C.U.B.A. training organization.

Disorderly conduct, indecent exposure, drunkenness or abusive language.

18. Using air- or gas-inflated floating devices as transportation on water unless the device is of multi-compartment construction and has a rigid motor mount for craft propelled by gasoline or electric motors. Single-compartment air or gas-filled flotation devices are restricted to designated swimming areas.

19. Boat regattas or other nonwildlife-oriented group activities.

20. Landing any aircraft.

21. Leaving decoys or things used as decoys in the field or on the water overnight.

22. Swimming except in designated waters or authorized activities.

Discharging firearms or bows in designated parking, camping or picnic areas.

24. Fishing in fish-rearing ponds or raceways.

25. Failing to leave a property when ordered by DOW personnel for any violation.

RULES FOR STATE TRUST LANDS ONLY

- 1. Public use is allowed Sept. 1 through Feb. 28, unless otherwise specified. All properties that are new for 1997-98 don't open to the public until Sept. 1, 1997 and are indicated with an asterisk (*).
- Properties are open only during daylight except where camping is allowed.
- 3. Many areas are restricted to foot or horseback travel. Motorized vehicles, where allowed, must stay on publicly maintained roads.
- No use of buildings, equipment and posted safety zones surrounding facilities is allowed.

5. Camping and fires are prohibited except in designated areas.

6. Camping is permitted only on properties as posted.

7. Discharging firearms only allowed while actually hunting. Hunting allowed only during established seasons. Please refer to Division of Wildlife hunting season brochures for specific dates when hunting is permitted.

Only weed-free certified livestock forage is permitted on State Trust Lands.

9. All target practice is prohibited.

LIMITS OF PUBLIC USE

- 1. The DOW may limit public use on a Division property for up to 60 days, using these criteria.
 - a. location and size of the area.
 - b. location, type and condition of roads, vehicle parking areas and number and type of sanitary facilities.
 - c. number of users the area will tolerate without significant degradation to wildlife resources, public or private property.
 - d. ensuring public safety, health and welfare.
- 2. When public use is limited, signs will indicate the number of people permitted. It is illegal to enter an area posted as fully occupied or after being advised by a DOW officer that the area is full.
- 3. The DOW may waive these restrictions for day use for organized, supervised groups whose numbers exceed the limits. Written approval must first be obtained from the appropriate DOW regional manager.

ASK FIRST!

It is illegal to hunt or fish on private land in Colorado without first obtaining the landowner's permission. It is the recreationist's responsibility to know whether the land is private. A landowner does not have to post or fence the land. State Land Board properties open to wildlife-related recreation and adjacent to private lands have signs marking the boundaries. 



Properties with an asterisk (*) are new for 1997 or have additional acres now open to the public. The properties are numbered first by county, then with lower case letters within each county.

3. BACA COUNTY

a. SAND CREEK SOUTH - GMU 144

From Campo, drive 15 miles west on Road J; turn south on Road 13 for 5.5 miles to Forest Service pasture, gate 2C. Drive south and east for 1 mile, taking a right fork south for 1/4 mile to the lease boundary.

ACRES: 319

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, mountain lions, doves, scaled quail, rabbits, coyotes, bobcats, turkeys.

ACCESS: Must park on USFS land and walk into parcel.

b. STATE LINE - GMU 144

From Campo, go 4 miles west on Road J, turn south on Road 24 for 5 miles, turn east through USFS pasture gate 6M. Continue 1 mile and turn south at gate 6A on a two-track trail. At 1 mile, pass through two gates and continue south and east for 1.3 miles to the northwest corner of the lease.

ACRES: 496

OPEN: Sept. 1-Feb. 28.

HUNTING: Antelope, scaled quail, rabbits, coyotes.

In the town of Campo at the intersection of Hwy. 287 and Baca Cty. Rd. J, go 10 miles west on Cty. Rd. J to Cty. Rd. 18. Take Cty. Rd. 18 4 miles south to property.

ACRES: 632

OPEN: Aug. 15-Feb. 28.

HUNTING: Antelope, Quail, Coyote.

ACCESS: At sign in NE corner of property on Cty. Rd. 18. Foot access only.

4. BENT COUNTY

a. BLUE LAKE - GMU 125

From Las Animas, take Hwy. 194 west to Cty. Rd. 10, north 11 miles then west 2-1/2 miles on Cty. Rd. TT to eastern property boundary. ACRES: 14.059

OPEN: Year-round for fishing only. Sept. 1-Feb. 28 for hunting. HUNTING: Antelope, deer, waterfowl, upland game.

FISHING: Warm-water lake.

ACCESS: There are several parking lots: (1) at end of Cty. Rd. TT; (2) at bridge on southeast corner; (3) at south end of property. Islands closed to public access from May 15-Aug. 31. Vehicles allowed on designated roads only. Camping allowed as posted.

5. CHAFFEE COUNTY

a. LITTLE COCHETOPA CREEK - GMU 561

From Poncha Springs, take Hwy. 50 west 2.5 miles to Cty. Rd. 210, then south 4.5 miles to the property.

ACRES: 640

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, elk, small game.

ACCESS: Foot or horseback only; no motorized vehicles. Timber activity may be present.

b. ASPEN RIDGE - GMU 57

From Salida, take Chaffee Cty. Rd. 175 (Ute Trail) 5 miles north. Then left on Chaffee Cty. Rd. 185 for 5 miles to property.

ACRES: 542

OPEN: Sept. 1-Feb. 28.

HUNTING: Bighorn sheep, deer, elk.

ACCESS: Chaffee Cty. Rd. 185 at north and south ends of property. No motorized vehicles off designated roads. Hunting by foot or horseback only. Timber activity may be present.

Or take Cty. Rd. 306 3 miles west to Cty Rd. 339, then south on Cty. Rd. 339 for 2 miles to parking lot.

ACRES: 2,177

OPEN: Aug. 15-Feb. 28.

HUNTING: Elk, deer, antelope.





OPEN: Sept. 1-Feb. 28 for hunting. Otherwise, year-round for fishing and watching wildlife only.

HUNTING: Bighorn sheep, elk, mule deer, mountain lions, black bears, blue grouse, ptarmigan, cottontail rabbits and snowshoe hares.





The trust lands total nearly 3 million surface acres and 4 million acres of subsurface mineral rights.

Since the trust lands are managed to generate revenue for public schools and to preserve long term productivity and value, the lands are not all open for public use.






LaGarde Creek State Trust Land
