Performer Bio's

Leo Thomas Canale received a Master of Music degree from Colorado State University where he studied music education and Kodály methodology. Originally from Homer, NY he has performed throughout the United States as a percussionist with various music ensembles. Leo holds degrees from the Crane School of Music, Potsdam, N.Y. and the University of North Texas. Mr. Canale was a member of the Air Force Academy Band in Colorado Springs and currently performs in Fort Collins and Chevenne Symphony Orchestras.

Eric Hollenbeck, Associate Professor of Percussion at Colorado State University since the fall of 2003, earned a Doctorate of Music in Percussion Performance from Northwestern University in Evanston, Illinois. He holds a Master's degree from the University of Illinois, Champaign-Urbana in Percussion Performance, and a Bachelor's degree in Percussion Performance from Kent State University. Hollenbeck is an artist/endorser for Pearl Corporation and Adams Musical Instruments, Innovative Percussion, Zildjian Cymbals, and Grover Pro Percussion. Hollenbeck has performed with diverse performing organizations ranging from principal positions held in Fort Collins and Chevenne Symphony Orchestras to appearances with the Alabama, Sinfonia De Camera, Chicago Civic, Tallahassee, Colorado, Columbus Symphony Orchestras, and as timpanist for the International Cathedral Music Festival, London, England. As a chamber musician, Eric has appeared with the Chicago Chamber Players, Eighth Blackbird, Alarm Will Sound, Xavier Cougat Orchestra and the Jack Daniels Silver Cornet Band. Eric has performed in England, Ecuador, Mexico, Canada, and over thirty universities in the United States. He has presented clinics and master classes at several PAS Days of Percussion, MENC and CMEA state conventions the Midwest Band and Orchestra clinic and as a featured performer at the 1996, 2001, and 2007 Percussive Arts Society International Conventions. In 2008, Eric was awarded the "Outstanding Teacher of the Year" by Colorado State University.

Jeremy Maytum - An advocate for the rapidly-expanding new music scene across the country, Jeremy Maytum enjoys bringing the eclectic world of percussion to audiences around the state. A graduate of Colorado State University in 2009, Jeremy received his Master's Degree in Percussion Performance, where he served as the Graduate Teaching Assistant for the award-winning percussion studio and instructed the CSU Rams Marching Band Drumline from 2007-2009. Jeremy completed his Bachelor's Degree in Percussion Performance from Colorado State University-Pueblo in 2007. His primary teachers include Dr. Eric Hollenbeck and Aaron Turner. He has participated in masterclasses and received instruction from marimbists Tom Burritt and She-e Wu. As an orchestral musician, Jeremy has performed with the Chevenne Symphony in Wyoming, the Fort Collins Symphony, the Greeley and Boulder Philharmonic, and the Colorado Symphony Orchestra. He also served as timpanist for the Blue Knights Drum & Bugle Corps in 2005. Jeremy currently serves as the front ensemble instructor for the Loveland High School Crimson Regiment in Loveland, Colorado, where he also teaches percussion masterclasses and concert percussion in the spring. He has held previous positions as the percussion caption head at Thompson Valley High School and the front ensemble instructor at Fossil Ridge High School. He teaches privately in the Northern Colorado area.

Shilo Stroman earned a B.M and a M.M. in Percussion Performance from Colorado State University where he studied with Dr. Eric Hollenbeck. He is a licensed teacher in the state of Colorado and currently serves as the Colorado Chapter President of the Percussive Arts Society (PAS). Mr. Stroman has appeared with the Greeley Philharmonic Orchestra, the Fort Collins Symphony and the Cheyenne Symphony. He has performed or appeared with: Art Lande, Don Aliquo, Anders Astrand, Peter Sommer, the Yellowjackets, Nancy Wilson, Amy Grant, The Four Tops, Mark Sloniker, Erik Applegate and Trisha Yearwood. In January of 2006, he commissioned and performed the world premiere of Sticks and Stones variations for drumset and wind ensemble by Jim Bonney. In 2008, he founded Square Peg, a contemporary jazz quartet. As an educator, Mr. Stroman is an adjunct instructor of percussion at Colorado State University where he teaches drumset and Jazz vibraphone as well as assists with all percussion activities. He is the director of percussion at Fossil Ridge High School in Fort Collins, Colorado, the front ensemble instructor for Longmont High School in Longmont, Colorado as well as arranger and consultant for Conifer High School and Windsor HighSchool. Previous to these positions he was the director of the jazz and percussion programs at Mountain View High School in Loveland, Colorado, As an in demand clinician Mr. Stroman has presented clinics at the University of Northern Colorado, Colorado State University, Colorado PAS Day of Percussion, Colorado Music Educators Convention, Colorado Bandmasters Convention, Wyoming PAS Day of Percussion and the Montana AA Band Festival, Many high schools and middle schools have also benefited from Mr. Stroman's clinics. Mountain View High School staff gained and expanded their knowledge by attending a clinic on integrating music into the core curriculum. Mr. Stroman is an educational endorser for the Pro-Mark Drumstick Corporation, Sabian Cymbals and Pearl/Adams Corporation.
